INRICH - This needs-based program has 47 beds available for longer term transitional housing for individuals and families. Services provided include housing focused case management, family reunification and stabilization, life skills programs, integrated community services, as well as mental health and substance abuse counseling and relapse prevention, with the goal of assisting the household move to safe and affordable permanent housing. During the reporting year, this program served 86 people, including 42 children. 91% of households who left this program moved into permanent housing.

4b (Code:) (Expenses \$ 236,270. including grants of \$ 0.) (Revenue \$ 283,107.)

Veterans -This program has 26 beds available for longer term transitional housing for single male veterans, and provides related programs and services, including housing focused case management, life skills programs, substance abuse counseling and relapse prevention. The goal of this program is to assist housing. During this reporting year, this program served 64 veterans who were experiencing the crisis of homelessness. 47% of those who exited the program moved immediately into permanent housing.

4c (Code:) (Expenses \$ 356,042. including grants of \$ 0.) (Revenue \$ 336,849.)

Espigh Family Shelter - This program has 27 beds for single women and families in need of short term emergency shelter. Housing focused case management services are provided and programs include life skills, budgeting, parenting skills and personal goal setting. During the reporting year, this program served 133 individuals, including 72 children. 82% of these individuals left the shelter and moved immediately into permanent housing.
