HomeAgain's INRICH Program is a 47-bed, Transition in Place Transitional Housing Program serving families in a housing crisis. The program provided 17,155 bed nights of Transitional housing to 14 households, comprised of 20 adults and 22 children during the fiscal year. The program helped these families to avoid homelessness and set them on a path to stabilization; life skills; integrated community services, as well as mental health and substance services. INRICH is a scattered site apartment program that provides transitional housing services to families absent of a group home setting. The program helps families achieve housing stability by leasing apartments for them to reside in and providing supportive services. Due to a shift in funding and best practices, this program will become a rapid rehousing program for families in 2016, allowing HomeAgain to assist more families in avoiding homelessness.

4b (Code: ) (Expenses \$ 419,739. including grants of \$ 0.) (Revenue \$ 419,739.)

Espigh Family Shelter provided 9,855 bed nights of crisis housing, and services to 104 households, including 108 adults and 105 children. A total of 90 households exited the facility during the year, and 78 or 87% of those households exited to permanent housing. This program offers emergency shelter to single adult women and families with children of all compositions. This 27-bed facility helps families avoid street homelessness by providing crisis housing, case management and rapid rehousing services designed to quickly end homelessness and return families to stable housing. The facility includes a Learning Center where children of homeless families can receive tutoring and participate in enrichment activities, and "Edward's Room," which is a play room designed to be a therapeutic space for children where they can relax, play, and simply be children.

Through the Men's Emergency Shelter, HomeAgain provided 7,300 bed nights of emergency shelter to 167 single adult men during the fiscal year. Of the 147 that exited the program during the year, 96, or 65% exited to permanent housing. This facility provides 20 emergency shelter beds and 8 veterans transitional housing beds. The program helps men to avoid street homelessness by offering safe shelter, case management, information and referrals to single adult men who are experiencing a housing crisis. The program also provides rapid rehousing to help the men return to stable housing as quickly as possible.
